Suit cites bedroom rules at complex

armel Oliver wanted a home to share with her two

But she says an Ypsilanti apartment complex said no. because her 8-month-old daughter, Carmeisha Skinner, would have shared a bedroom with her 6-yearold brother, Joshua Young.

Oliver said she was told children of different sexes could not share a bedroom in the apartment she wanted in January.


"I felt like they were closing the door in my face," she said. "I was hurt."

Thursday, she sued Cobble Creek Apartments, claiming sex and age discrimination.

Richard Lupu, manager of the Steven Drive complex, confirmed the bedroom rule. "That's a criteria in our policy, yes,"

As for suit, "We heard something about it. We have no further comment at this time."

Oliver's case began with the Ann Arbor-based Fair Housing Center of Washtenaw County, which investigated, then arranged for an attorney who filed her federal lawsuit in Ann Arbor.

The case is a first for the center, which was not aware before of such policies anywhere. "We just haven't gotten complaints from people.".

Amber Apartments, which has 450 units in six complexes in Oakland County, also has no such policy, an employee said.

After the suit's filing, Oliver said, "I feel better now, knowing something will be done about it."

Her attorney is Steve Dane, of Toledo. The case is assigned to U.S. District Judge Patrick I. Duggan, in Detroit.
